EXECUTIVE SUMMARY

A nationwide assessment and review of the Foodborne Disease Surveillance and Response System in Nigeria was initiated by the Federal Ministry of Health (FMOH) in collaboration with the National Food Safety Management Committee (NFSMC) and partners, to evaluate the strength, weaknesses and gaps and make recommendations that will lead to improved public health through reducing the existing magnitude of the burden of foodborne diseases in the country. This review was also initiated as part of the requirements from the World Health Organization (WHO) benchmarks for International Health Regulations (IHR) Capacities, 2019¹. This report summarises the findings from consultations with key stakeholders and field assessment of critical stakeholders involved in the development and implementation of foodborne disease surveillance and response activities at the Federal and State levels of government. The assessment was undertaken from October 2020 to April 2021.

METHODOLOGY

Pre-Assessment Workshop.

A pre-assessment workshop was conducted for the technical team to facilitate discussions and agreements on the priorities and objectives of the review; further sensitise members on the multi-disease approach to surveillance; to agree on the list of likely national priority diseases; and to discuss and adapt the assessment protocols and plans. A one-day pre-test was conducted in Abuja and the assessment tools² were finalised and adapted including the conclusion of travel arrangements to assessment sites.

Focused Group Discussions (FGDs) with Senior Officials of relevant MDAs and Health Facilities

The approach at each selected location was to have an initial FGD meeting(s) with senior officials of the selected MDAs and health facilities to introduce the objectives of the assessment, obtain their views on the status of the implementation of foodborne disease surveillance and response system in place, and obtain insights on its strengths, weaknesses, gaps, and similar deficiencies³.

Key Informant Interviews (KII) with designated head of relevant sections of Health Facilities

Key Informant Interviews (KII) were conducted with desk officers in the relevant clinical departments as well as hospital records, laboratory sections of health facilities, and public health

laboratories to obtain information/data on cases of foodborne diseases reported and confirmed at the facility. The views and insights from respondents were collated and analysed.

Assessment of facilities of relevant Institutions.

The performance of the selected institutions and organisations were assessed and evaluated based on criteria adapted from the Protocol for the Assessment of National Communicable Disease Surveillance and Response System developed by the WHO. Asokoro District Hospital, Abuja, FCT was used to pre-test the survey instruments. A total of 22 institutions comprising of 9 health facilities and 13 Federal and State relevant MDAs were assessed. Relevant data needed to achieve the objectives of the assessment study were collected, collated, and analysed.

SUMMARY OF FINDINGS

Adequacy of Relevant Federal and State MDAs to Implement Foodborne Disease Surveillance Programs and Activities

- 1. Over 95% of the relevant MDA cannot systematically collect, collate, and analyse data on foodborne and zoonotic diseases, food contaminants, and disseminate same to relevant stakeholders for necessary actions to be taken.
- 2. No MDA currently have standard case definitions for Nigeria's priority foodborne diseases including their registration.
- Over 90% of MDA are yet to develop or use written manuals/SOPs including standard reporting forms dedicated to collecting and collating foodborne disease incidences and outbreaks.
- 4. MDAs currently lack the standard system and capacity to respond to cases of foodborne disease incidences and outbreaks within 48 hours of notification.
- 5. Over 90% of relevant MDAs cannot currently publish periodic health and surveillance information including bulletins to disseminate information on foodborne diseases and food contamination on a regular and sustainable basis.
- 6. Over 95% of laboratory facilities including its personnel cannot investigate, detect and verify foodborne diseases, and food contaminants including animal and plant disease-causing pests.
- 7. Existing training facilities for surveillance and response activities are poor and mostly achieved through on-the-job training. Specific training of personnel on Foodborne Disease Surveillance and Response Activities are nearly absent.
- 8. Availability of resources for effective surveillance systems in place to detect and monitor foodborne diseases, zoonotic diseases including animal disease-causing pests and food

contamination is grossly inadequate or near absent. Where this is available, it is mostly donor driven.

Adequacy of Selected Private, Federal and State Hospital Facilities to Carryout Foodborne Disease Surveillance and Response Programs and Activities

- 1. No hospital facilities currently undertake the systematic collection, collation, and analysis of data on foodborne diseases and associated food contaminants; including their dissemination to relevant stakeholders to enable necessary actions to be taken.
- 2. Absence of standard case definition and priority foodborne diseases.
- 3. Over 95% of the hospital facilities are yet to develop or use standard protocols for the collection and collation of foodborne disease incidences and outbreaks. Only IDSR forms are currently in use.
- 4. Hospital facilities are yet to develop or put in place standard systems that can respond to foodborne disease incidences and outbreaks within 48 hours of notification.
- 5. Existing hospital facilities to engage in production and dissemination of health and surveillance information including bulletins on foodborne diseases and food contaminations regularly to relevant stakeholders and the reading public.
- 6. Over 95% of laboratory facilities in hospitals currently lack the needed infrastructure and personnel to adequately investigate and analyse FBD cases including generation and dissemination of relevant reports.
- 7. Existing training facilities on surveillance and response activities are inadequate. Specific training of personnel on Foodborne Disease Surveillance and Response Activities are not of priority.
- 8. Availability of resources for effective surveillance systems to detect and monitor foodborne diseases, and food contaminations is grossly inadequate or absent. Where this is available, it is mostly donor driven.

RECOMMENDATIONS

For Federal MDAs and Health Facilities

- Strengthen the existing capacity of relevant MDAs and healthcare facilities across the
 country to systematically collect, collate, analyse, and report data on priority foodborne
 and zoonotic diseases, food contaminants and related food safety hazards to facilitate
 timely recognition of existing and emerging foodborne diseases through a well-developed
 national surveillance network.
- 2. Develop an official priority list of foodborne diseases in the country for inclusion in routine disease surveillance reporting system in NCDC.

- 3. Develop official case definitions and management protocols for priority foodborne diseases to guide medical professionals in providing notifications on these diseases in a harmonised and systematic manner.
- 4. Develop and ensure the functionality of the INFOSAN Emergency Contact Point and Focal Points in MDAs to rapidly assess foodborne events in collaboration with State/LGA food safety focal person(s), epidemiological surveillance officer(s).
- 5. Develop and disseminate a country response procedure/plan to address food safety emergencies to include:
 - a. Data reporting protocols for all priority foodborne diseases and foodborne hazards;
 - b. An updated list of contact laboratories;
 - c. Questionnaires for priority foodborne pathogens and hazards;
 - d. Model press releases; and
 - e. Food recall and withdrawal notice.
- 6. Urgently develop and disseminate standard case definitions for diseases caused by the following contaminants: Salmonella typhi and paratyphi, Escherichia coli, Ascaris lumbricoides Clostridium botulinum, Clostridium perfringens, Listeria monocytogenes, Campylobacter, Brucella, Campylobacter, natural toxins in food, Arsenic, and mycotoxins.
- 7. Leverage the well-established disease surveillance and notification system in the Nigeria Centre for Disease Control (NCDC) to provide for regular data collection and collation to measure the burden of foodborne diseases and provide the needed priority areas for the prevention and control of FBDs.
- 8. Federal Ministry of Agriculture and Rural Development in collaboration with the Health Sector MDAs to identify priorities FBDs of animal origin.
- 9. Integrate the Surveillance Outbreak Response Management & Analysis System (SORMAS) and National Animal Disease Information Service (NADIS) platforms to ensure that foodborne diseases of animal origin identified in the animal sector are easily linked together to ensure a more efficient and harmonised surveillance, response and management of FBDs that is in line with the OneHealth concept.
- 10. Strengthen national capacity to link identified pathogens in food along the food chain to human diseases using appropriate risk assessment techniques.
- 11. Upgrade national capacity and infrastructure of the laboratory including laboratory staff to monitor, detect, collate, evaluate, and respond to the emergence of antimicrobial resistance to foodborne pathogens.

- Develop training and capacity building programs for relevant personnel charged with the responsibility of engaging in FBD surveillance and Response Activities at the national level.
- 13. Develop and implement a prioritised action plan based on the assessment findings.
- 14. Conduct a nationwide estimate of the health, economic and trade burden of foodborne disease.

For State MDAs and Health Facilities

- 1. Build the capacity of Disease and Surveillance Notification officers (DSNOs) to identify and investigate FBDs
- 2. Identify and empower State Food Safety Focal Person(s) in collaboration with State/LGA epidemiological surveillance officer(s) to rapidly assess foodborne events and report to the INFOSAN Emergency Contact Point and Focal Points at the Federal level.
- 3. State Ministries of Health in collaboration with relevant MDAs are requested to urgently provide standard case definitions for diseases caused by the following contaminants: Salmonella typhi and paratyphi, Escherichia coli, Ascaris lumbricoides, Clostridium botulinum, Clostridium perfringens, Listeria monocytogenes, Campylobacter, Brucella, Campylobacter, natural toxins in food, Arsenic, and mycotoxins
- 4. Build State capacity and infrastructure of laboratory and laboratory personnel to collect and transport appropriate specimens to a laboratory during foodborne outbreaks to identify the aetiological agent.
- 5. Develop training and capacity building programs for relevant personnel charged with the responsibility of engaging in FBD surveillance and response activities at State and LGA levels.
- 6. Build the capacity of clinicians, medical records officers and hospital laboratory technicians in case management, documentation, and reporting of FBDs.

CONCLUSION

The existing Foodborne Disease Surveillance and Response System in place in Nigeria is not fit for purpose and is unable to meet the requirements of WHO benchmarks for International Health Regulations (IHR). For the System to be effective, Foodborne disease surveillance and the food safety monitoring system across the entire food chain from farm to the table must be integrated and synergised. It is also imperative that strong leadership backed by political commitment, collaboration, and coordination of activities of relevant agencies at the Federal, State and Local Government levels are of paramount importance to ensure the existing FBD surveillance and Response System in place in the country is strengthened and enhanced.

INTRODUCTION

Foodborne Diseases (FBDs) are illnesses caused by the consumption of food contaminated with pathogenic bacteria, viruses, parasites, or toxic chemicals. FBDs are generally characterized by a wide spectrum of acute or chronic syndromes with mild to severe health consequences. FBDs are important causes of morbidity, mortality, and a significant impediment to socioeconomic development in less developed countries. Although FBDs are diverse and varied widely with regards to types, their causative agents and their severity to human health. Food can be contaminated at any stage along the food chain and hence, effective surveillance on foodborne, zoonotic diseases, and monitoring of food contaminants will greatly assist in establishing reliable data including providing an enabling environment for evidence-based evaluation of priorities for the prevention and control, and reduction of uncertainties in mitigating strategies.

Unsafe food constitutes a significant route for transmitting diseases to humans. For example, the World Health Organization (WHO)⁴ reported in 2012, that 600 million cases of foodborne illnesses occurred globally which resulted in 420,000 deaths annually. Similarly, the African regional share of this burden was estimated at 91 million with 137,000 deaths annually, making the region the world's highest per capita incidence of foodborne illness⁵. According to WHO studies of the global burden of foodborne diseases, 31 food hazards including bacteria, viruses, protozoa, helminths, and toxic chemicals have been identified⁶. Although clinical symptoms of FBDs mostly manifest as gastrointestinal disorders, others with more serious consequences include kidney and liver failure, brain and neurological disorders, and cancer.

Nigeria is typically agrarian with nearly 70% of its population living and carrying out their livelihood in rural areas. With a highly fragmented food supply system, food production, processing, and marketing activities in the country remain essentially informal. Given the high level of poor food handling practices across the entire food chain from farm to table, rising cases, and outbreaks of FBDs arising from the consumption of contaminated and or adulterated foods are being reported. However, FBDs are yet to be fully integrated with the Country's Surveillance Outbreak Response Management & Analysis System (SORMAS). In view of this, incidence, and outbreaks of FBDs are poorly documented by relevant agencies across each level of government in the country. This scenario has led to poor public understanding and awareness of the significance is FBDs to public health and food trade. This has also limited and or impeded policymakers to

provide sufficient resources and support for effective prevention and control of foodborne diseases and minimize their socioeconomic impact on the citizenry.

Effective national foodborne disease surveillance and response system is significant in many ways. It assists in the assessment of the burden of foodborne diseases at various levels of government and communities and contributes to the identification of public health priorities assists the nation to prevent, detect, and control outbreaks; and identify emerging food safety issues⁸. In line with these, and in pursuant to its commitment to the implementation of the National Policy on Food Safety and Its Implementation Strategy Document, the Federal Ministry of Health (FMOH) and her Partners, undertook an assessment study of the existing National Foodborne Disease Surveillance and Reporting System being implemented in the country, to evaluate its strength, weaknesses and gaps and make recommendations that will lead to improved public health and reduce the existing burden of foodborne diseases in the country.

OBJECTIVES

The specific objectives for this assessment study are to evaluate the capacity of existing Foodborne Disease and Response System in the country and to:

- 1. Identify priority foodborne diseases in the country and estimate the magnitude of its burden;
- 2. Identify priority food safety hazards and recommend suitable and effective control measures;
- 3. Generate timely and accurate epidemiological data that can be used for food safety risk analysis and ensure prompt dissemination to critical stakeholders to ensure safe food supplies;
- 4. Identify strengths, weaknesses, and gaps in performing the core and support functions of foodborne disease surveillance including an estimate of the resources needed for effective implementation; and
- 5. Enable the development of a prioritized action plan, based on the assessment findings.

METHODOLOGY

The assessment was conducted by a 12-man technical team made up of nominated representatives from relevant institutions and organizations performing core and support functions for foodborne disease surveillance and response in the Country. The Technical Team consisted of a National Consultant and nominated representatives from the Federal Ministries of Health (FMOH), Federal Ministry of Agriculture and Rural Development (FMARD), National Agency for Food Control and Administration (NAFDAC), Nigeria Centre for Disease Control (NCDC) and National Bureau of Statistics (NBS).

The assessment was conducted in two randomly selected LGAs (1 Urban and 1 Rural) of the FCT, Kano, Oyo, and Akwa Ibom States from 4th October to 30th April 2021. The Asokoro District Hospital, Abuja, FCT was used to pre-test the survey instruments.

PRE-ASSESSMENT TRAINING WORKSHOP

A pre-assessment workshop was conducted for the technical team to facilitate discussions and agreements on surveillance priorities and objectives. It was also to further sensitise members on the multi-disease approach to surveillance, agree on the list of national priority diseases and discuss and adapt the assessment protocols and plans. A one-day pre-test was conducted in Abuja and the assessment tools were finalised and adapted including the conclusion of travel and logistical arrangements to assessment sites.

- d. Vaccination campaigns for FBI related outbreaks (such as Hepatitis A, Cholera, Typhoid, Rotavirus) are NOT part of the national vaccine coverage.
- e. Resources for surveillance activities are generally inadequate and limited.

DISCUSSIONS OF RECOMMENDATIONS

ADEQUACY OF RELEVANT FEDERAL AND STATE MDAS TO CARRYOUT FOODBORNE DISEASE SURVEILLANCE ACTIVITIES

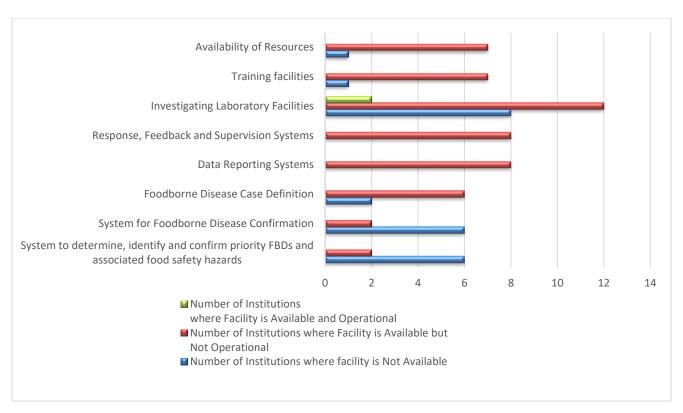


Figure 1: Adequacy of Federal and State MDAs to undertake FBD Surveillance and Response Activities

Summary of findings and analysis of the assessment of relevant Departments and Agencies of Federal and State Ministries of Health and Agriculture in the selected locations are provided in Tablel and Figure 1 below respectively.

It can be seen from the above that:

- 1. Only 2% of the relevant Departments and Agencies could systematically collect, collate, and analyse data on foodborne and zoonotic diseases and associated food contaminants; including their dissemination to relevant stakeholders to enable necessary actions to be taken.
- 2. No Departments/Agencies currently have officially standardized case definitions of Nigeria's priority foodborne and zoonotic diseases including their registration.
- 3. Over 90% of departments/agencies are yet to develop or use adequate and standardised reporting forms dedicated to collect and collate foodborne disease incidences and outbreaks.
- 4. No departments/agencies currently have a standardised system and capacity to respond to cases of foodborne disease incidences and outbreaks within 48 hours of notification.
- 5. No departments/agencies currently can publish periodic health and surveillance information including bulletins produced to disseminate information on foodborne diseases and food contamination regularly.

- 6. Over 95% of laboratory facilities including laboratory personnel cannot adequately investigate, carry out tests, prepare and disseminate reports on food contaminations, foodborne and zoonotic diseases.
- 7. Existing training facilities for surveillance and response activities are poor and mostly carried out through on-the-job training. Specific training of personnel on Foodborne Disease Surveillance and Response Activities are nearly absent.
- 8. Availability of resources for effective surveillance systems in place to detect and monitor foodborne diseases, zoonotic diseases including animal disease-causing pests and food contamination is grossly inadequate or absent. Where this is available, it is mostly donor driven.

ADEQUACY OF SELECTED PRIVATE, FEDERAL AND STATE HOSPITAL FACILITIES TO CARRYOUT FOODBORNE DISEASE SURVEILLANCE AND RESPONSE PROGRAMS AND ACTIVITIES

Summary of findings and analysis of the assessment of selected hospital facilities in the targeted locations are provided in Table 3 and Figure 3 below respectively.

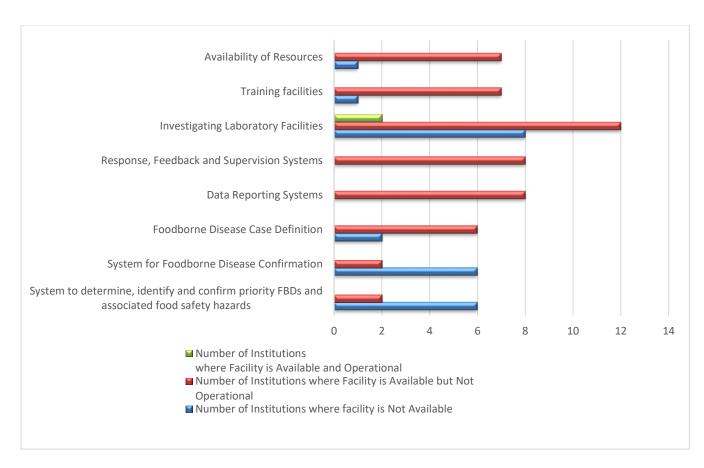


Figure 2: Adequacy of Selected Private, Federal and State Hospital Facilities to Carryout Foodborne Disease Surveillance and Response Programs and Activities

It can be seen from the above that:

- 1. All hospital facilities could systematically collect, collate, and analyse data on foodborne diseases and associated food contaminants; including their dissemination to relevant stakeholders to enable necessary actions to be taken;
- 2. Absence of officially standardised case definitions of Nigeria's priority foodborne and diseases including their registration in all hospital facilities;
- 3. Over 95% of hospital facilities are yet to develop or use standardized reporting forms dedicated to collect and collate foodborne disease incidences and outbreaks. Only IDSR Forms are currently in use;
- 4. Hospital facilities are yet to develop standard systems in place and the needed capacity to respond to cases of foodborne disease incidences and outbreaks within 48 hours of notification;
- 5. Lack of initiatives of Hospitals to publish periodic health and surveillance information including bulletins specifically dedicated to disseminating information on foodborne

- diseases and food contaminations regularly to relevant stakeholders and the reading public;
- 6. Over 95% of laboratory facilities in hospitals currently lack personnel to adequate investigate, carry out tests, prepare and disseminate reports on food contaminations, and foodborne;
- 7. Existing training facilities on surveillance and response activities are inadequate and mostly carried out through on-the-job training. Specific training of personnel on Foodborne Disease Surveillance and Response Activities are not of priority; and
- 8. Availability of resources for effective surveillance systems in place to detect and monitor foodborne diseases, and food contaminations is grossly inadequate or absent. Where this is available, it is mostly donor driven.

BREAKDOWN OF CONFIRMED CASES OF FBDs IN HEALTH CARE FACILITIES

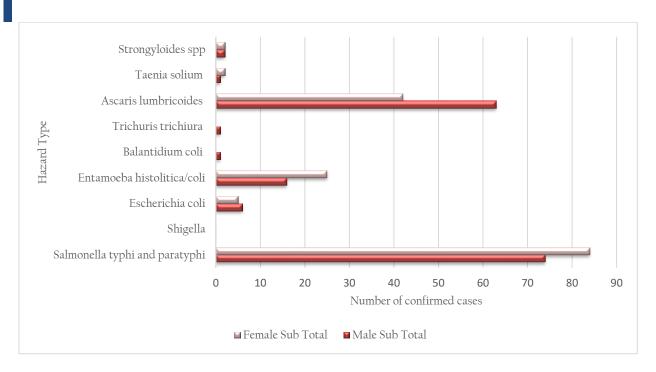


Figure 3: 3rd Quarter 2020 Confirmed FBDs in FMC Jabi, Abuja

The breakdown of confirmed cases of foodborne diseases from Federal Medical Centre, Abuja, in Figure 3 above, mimics results gotten from other health facilities visited and it showed the following:

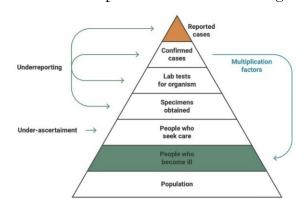
1. That cases of diarrhoea (with or without blood) are the most common cases referred to the laboratory for analysis and confirmation.

- 2. That serious underdiagnosis of foodborne diseases, although not unexpected, shows the failure of the health sector to capture cases that do not seek medical care and when medical care is sort, confirmatory tests are not done to ascertain the likely pathogen due to poor healthcare/laboratory capacity and healthcare-seeking behaviours.
- That due to inability of patients to afford the fees for laboratory tests, most diagnosis of foodborne diseases were not confirmed at laboratory level, thereby reducing the case count.
- 4. That recorded cases in health facilities are based on the notifiable diseases in the IDSR forms in health facilities. Most facilities did not record and/or report cases because it was not expedient to do so.
- 5. That *Salmonella typhi* and *paratyphi* are the most identified foodborne pathogen followed closely by *Ascaris lumbricoides*.
- 6. That FBDs caused by chemical and heavy metal poisoning were not reported or highlighted despite unconfirmed cases noted during the KII.
- 7. That the private health facilities visited mostly do not record and/or report cases of FBDs to the State and/or LGA Disease Surveillance and Notification Officer (DSNO).

With the paucity of data, there is a great need to estimate the burden of FBDs even when there is low case confirmation rate. Several studies have pustulated various ways to estimate the incidence foodborne diseases. None more recent than the WHO's 2021 publication on "estimating the

burden of foodborne diseases: a practical handbook for countries". The document showed that confirmed cases are just the tip of the iceberg – as seen in figure 4 – and emphasises the need for all countries to invest in the proper estimation of the burden of FBDs to ensure that commensurate policy decisions are made to ensure profound reduction in the burden of FBDs in Nigeria.

RECOMMENDATIONS

FOR FEDERAL MDAS AND HEALTH FACILITIES

- Strengthen the existing capacity of relevant MDAs and healthcare facilities across the
 country to systematically collect, collate, analyse, and report data on priority foodborne
 and zoonotic diseases, food contaminants and related food safety hazards to facilitate
 timely recognition of existing and emerging foodborne diseases through a well-developed
 national surveillance network.
- 2. Develop an official priority list of foodborne diseases in the country for inclusion in routine disease surveillance reporting system in NCDC.
- Develop official case definitions and management protocols for priority foodborne diseases
 to guide medical professionals in providing notifications on these diseases in a harmonised
 and systematic manner.
- 4. Develop and ensure the functionality of the INFOSAN Emergency Contact Point and Focal Points in MDAs to rapidly assess foodborne events in collaboration with State/LGA food safety focal person(s), epidemiological surveillance officer(s).
- 5. Develop and disseminate a country response procedure/plan to address food safety emergencies to include:
 - a. Data reporting protocols for all priority foodborne diseases and foodborne hazards;
 - b. An updated list of contact laboratories;
 - c. Questionnaires for priority foodborne pathogens and hazards;
 - d. Model press releases; and
 - e. Food recall and withdrawal notice.
- 6. Urgently develop and disseminate standard case definitions for diseases caused by the following contaminants: Salmonella typhi and paratyphi, Escherichia coli, Ascaris lumbricoides Clostridium botulinum, Clostridium perfringens, Listeria monocytogenes, Campylobacter, Brucella, Campylobacter, natural toxins in food, Arsenic, and mycotoxins.
- 7. Leverage the well-established disease surveillance and notification system in the Nigeria Centre for Disease Control (NCDC) to provide for regular data collection and collation to measure the burden of foodborne diseases and provide the needed priority areas for the prevention and control of FBDs.
- 8. Federal Ministry of Agriculture and Rural Development in collaboration with the Health Sector MDAs to identify priorities FBDs of animal origin.

- 9. Integrate the Surveillance Outbreak Response Management & Analysis System (SORMAS) and National Animal Disease Information Service (NADIS) platforms to ensure that foodborne diseases of animal origin identified in the animal sector are easily linked together to ensure a more efficient and harmonised surveillance, response and management of FBDs that is in line with the OneHealth concept.
- 10. Strengthen national capacity to link identified pathogens in food along the food chain to human diseases using appropriate risk assessment techniques.
- 11. Upgrade national capacity and infrastructure of the laboratory including laboratory staff to monitor, detect, collate, evaluate, and respond to the emergence of antimicrobial resistance to foodborne pathogens.
- 12. Develop training and capacity building programs for relevant personnel charged with the responsibility of engaging in FBD surveillance and Response Activities at the national level.
- 13. Develop and implement a prioritised action plan based on the assessment findings.
- 14. Conduct a nationwide estimate of the health, economic and trade burden of foodborne disease.

FOR STATE MDAS AND HEALTH FACILITIES

- 1. Build the capacity of Disease and Surveillance Notification officers (DSNOs) to identify and investigate FBDs
- 2. Identify and empower State Food Safety Focal Person(s) in collaboration with State/LGA epidemiological surveillance officer(s) to rapidly assess foodborne events and report to the INFOSAN Emergency Contact Point and Focal Points at the Federal level.
- 3. State Ministries of Health in collaboration with relevant MDAs are requested to urgently provide standard case definitions for diseases caused by the following contaminants: Salmonella typhi and paratyphi, Escherichia coli, Ascaris lumbricoides, Clostridium botulinum, Clostridium perfringens, Listeria monocytogenes, Campylobacter, Brucella, Campylobacter, natural toxins in food, Arsenic, and mycotoxins
- 4. Build State capacity and infrastructure of laboratory and laboratory personnel to collect and transport appropriate specimens to a laboratory during foodborne outbreaks to identify the aetiological agent.
- 5. Develop training and capacity building programs for relevant personnel charged with the responsibility of engaging in FBD surveillance and response activities at State and LGA levels.
- 6. Build the capacity of clinicians, medical records officers and hospital laboratory technicians in case management, documentation, and reporting of FBDs.

CONCLUSION

Foodborne Diseases are an important national public health problem with a significant impact on its economy and food trade. Since most cases and outbreaks of FBDs are often underreported the true value and dimension of the burden of FBDs in Nigeria is unknown. The absence of reliable data on cases FBDs and food contaminants has further impeded the public understanding and awareness of its public health significance, even though recent cases and outbreaks have attracted public attention, policymakers are yet to develop and implement adequate measures to address existing and emerging food safety issues.

The existing Foodborne Disease Surveillance and Response System in place in Nigeria are not fit for purpose and are unable to provide the needed information to assure the estimation of a reliable burden of foodborne diseases and rapid detection and response to outbreaks. For the system to be effective, the surveillance FBDs must be integrated with food monitoring data across the entire food chain from farm to table. It is also imperative that strong leadership backed by political commitment, collaboration, and coordination of activities of relevant agencies at the Federal, State and Local Government levels are of paramount importance to ensure the existing FBD surveillance and Response System in place in the country is strengthened and enhanced.
